SCOUR VALVES, AIR VALVES, METERS AND OTHER FITTINGS SHALL BE REQUIRED AS OUTLINED HEREUNDER:

1. Visual leak detection investigations shall be undertaken at various locations within the reticulation network.
2. Visible leak detection shall be undertaken on foot. All reticulation infrastructure such as chambers, valve covers, and meters boxes shall be opened during the investigation and visually inspected for any leakage.
3. All leakage identified shall be captured on bespoke forms where information such as Leak position (GPS), leak size, Infrastructure leaking (meter, pipe, valve, hydrant, other) will be indicated.
4. Photographs of each leak shall be taken, and all leak positions shall be marked up on a network drawing or map.
5. A minimum of 7 days Flow logging shall be required at the Main supply pipe to the focus area. This logging shall be required prior to starting with the visual leak detection.
6. The service provider is expected to determine the minimum night flow and compute the level of leakage within the area.
7. A minimum of 3 days of Pressure Logging shall be required at 4 points within the focus area. Fire hydrants, hose reels and Taps shall be used when logging pressures at the critical point, Lowest point, and average point.
8. Graphical representation and raw data shall be required for all data Logging to be done.
